# A Letter from Senator Merkley and Senator Wyden

Dear Fellow Oregonians,

The nation's economy is at a tipping point. The American economy lost over 650,000 jobs in February alone and almost 50,000 Americans are losing their homes to foreclosure each week. In Oregon, our unemployment rate is at almost 10%.

In response to this dire situation, we have worked with President Obama to pass the American Recovery and Reinvestment Act, a recovery package that will create 3.5 million jobs for American workers, including 44,000 jobs in Oregon. This legislation is a commitment to creating and maintaining American jobs through targeted funding of job-intensive projects and broad-based tax relief. As we invest in jobs to build infrastructure and develop renewable energy, we're investing in the future of our economy.

To assist Oregonians in understanding how this recovery plan will benefit our state, we have put together this ***Oregon Resource Guide to the American Recovery and Reinvestment Act of 2009***. The guide includes information on many federal programs and funding opportunities available to individuals, communities and businesses in Oregon as a result of the economic recovery package.

As a result of this legislation, Oregon will receive \$1.62 billion in direct aid and \$780 million in additional Medicaid assistance over the next two years. In addition, the state, Oregon localities, and Oregon's private sector will compete for millions of dollars in competitive grants. It is important that we get this information to those who need it so these funds can begin helping Oregonians as quickly as possible.

This resource guide provides a starting point for Oregonians to understand how the ARRA will benefit Oregon and where to go for more information about specific programs. It should not be used as a comprehensive record of how each dollar will be spent, but rather an overview of how the recovery plan will strengthen our economy.

## Highway Improvement Programs

*\$27.5 billion was included for Highway Infrastructure Investment.*

**Oregon will receive \$334 million in formula funding.**

<b>Administrator:</b>	Oregon Department of Transportation, local governments
<b>Purpose:</b>	For transportation projects including resurfacing and pavement preservation projects, traffic signal system upgrades, bridge projects, transit projects and intelligent transportation systems.
<b>Description:</b>	Funds are distributed by formula, with 30% of the funds within each state being sub allocated to local governments.

## Transit Capital Formula Program

*\$6.9 billion was included for transit capital assistance grants.*

**Oregon's urban areas will receive \$61.1 million in formula funding.**

**Oregon's rural areas will receive \$ 14.6 million in formula funding.**

<b>Administrator:</b>	Oregon Department of Transportation, transit districts
<b>Type:</b>	Each urbanized area with a population greater than 50,000 will receive a direct allocation of funds from the Federal Transit Administration (FTA). Non-urbanized areas will receive funding through the Oregon Department of Transportation (ODOT) Public Transit Division.
<b>Description:</b>	These funds will be used to purchase buses and equipment needed to provide additional public transportation service and to make improvements to intermodal and transit facilities.

## Fixed Guideway Modernization

*\$750 million was included for transit capital assistance grants.*

**Oregon will receive \$1.1 million in formula funding.**

<b>Administrator:</b>	Federal Transit Administration
<b>Type:</b>	Funds are allocated by a statutory formula to urbanized areas with rail systems that have been in operation for at least seven years.
<b>Purpose:</b>	These funds will be used for capital projects to modernize or improve existing fixed guideway systems, including purchase and rehabilitation of rolling stock, track, line equipment, structures, signals and communications, power equipment and substations, passenger stations and terminals, security equipment and systems, maintenance facilities and equipment, operational support equipment including computer hardware and software, system extensions, and preventive maintenance.

<b>Purpose:</b>	For light rail lines, rapid rail (heavy rail), commuter rail, automated fixed guideway system, or bus-way/high occupancy vehicle (HOV) facilities

## National Surface Transportation System – Discretionary Grants

<b>Description:</b>	Discretionary grants to be awarded to state and local governments or transit agencies on a competitive basis for projects that will have a significant impact on the nation, a metropolitan area, or a region. Eligible projects include highway and bridge projects, public transportation projects, passenger and freight rail projects, and port infrastructure investments.
<b>Description:</b>	Funds are distributed by formula, with a portion of the funds within each State being sub-allocated by population areas.

## Capital Assistance for High Speed Rail and Intercity Passenger Rail Service

*\$8 billion was included for Capital Assistance to States and the High Speed Passenger Rail Program.*

<b>Administrator:</b>	Federal Railroad Administration U.S. Department of Transportation
<b>Description:</b>	The Capital Assistance to States—Intercity Passenger Rail Service program provides grants on a discretionary basis to states to fund necessary capital improvements to improve intercity passenger rail service. Grants under this program are awarded to the most meritorious projects as measured against statutory criteria, discretionary grants to States to provide capital assistance for improving intercity passenger rail service as well as maintaining existing passenger rail corridors.

<b>Provision:</b>	Funds cannot be used for Amtrak's operating losses
<b>Purpose:</b>	To maintain and improve the national system of intercity passenger rail. In addition to security improvements, repair, rehabilitation, or upgrade of railroad assets or infrastructure, and for capital projects that expand passenger rail capacity including the rehabilitation of rolling stock (locomotives and passenger cars).

## Clean Water State Revolving Fund

*\$4 Billion Included in the Clean Water State Revolving Fund.*

**Oregon will receive \$45 million in formula funding.**

<b>Administrator:</b>	Oregon Department of Environmental Quality
<b>Provisions:</b>	Waives mandatory 20% matching requirements for revolving funds.
	Directs the Administrator to reallocate Revolving Fund monies where projects are not under contract or construction within 12 months of the date of enactment.
	Directs priority funding on projects to State priority lists that are ready to proceed to construction within 12 months of enactment.
	Requires at least 50% of the capitalization grants each state receives be used to provide assistance for additional subsidization (forgiveness of principal, negative interest loans, or grants, or any combination of these).
	Requires at least 20% of each Revolving Fund be available for projects in green infrastructure, water and/or energy efficiency, innovative water quality improvements, decentralized wastewater treatment, storm water runoff mitigation and water conservation, unless states lack applicants with these types of projects.
<b>Purpose:</b>	To provide relief to communities by requiring a greater Federal share for local clean and drinking water projects and greater flexibility for states to reach communities that would otherwise not have the resources to repay a loan with interest.
<b>Description:</b>	Funding provided to states is used to makes loans to communities, individuals, and others for high-priority water-quality activities.
<b>Activities:</b>	Loans are used to build or improve wastewater treatment plants, agriculture, rural and urban runoff control; estuary improvement projects; wet weather flow control, including storm water and sewer overflows; alternative treatment technologies; and water reuse conservation projects.

**To Apply:** Oregon DEQ anticipates receiving the grant by June 1, 2009. Any public agency in Oregon is eligible for funding under the Act. The maximum amount for a loan is \$5 million per borrower. Applicants must complete a CWSRF loan application and provide required documentation about the project's benefits, environmental impact and cost. **Oregon will receive \$45 million in formula funding.**

<b>Administrator:</b>	Oregon Department of Environmental Quality
<b>Provisions:</b>	Waives mandatory 20% matching requirements for revolving funds.
	Directs the Administrator to reallocate Revolving Fund monies where projects are not under contract or construction within 12 months of the date of enactment.
	Directs priority funding on projects to State priority lists that are ready to proceed to construction within 12 months of enactment.
	Requires at least 50% of the capitalization grants each state receives be used to provide assistance for additional subsidization (forgiveness of principal, negative interest loans, or grants, or any combination of these).
